She reported that she was not sure if the Azalea Festival was on the calendar for April but was willing to try to make it happen if possible. She also reported that we now have about 600 followers to the Arcade City Hall Facebook page. She will continue to post the open Maintenance position until it is filled. She also just began promoting the open Administrative Assistant position at the Police Department this week.

7. CITIZENS REQUESTING TO SPEAK:

- 1. Tom Huck who resides at 1194 Rambler Inn Road. He stated he is opposed to the business wanting to go in at 1193 Rambler Inn Road. He said the street is already way too busy, saying traffic is bad in that area. He and a lot of his neighbors like to walk or walk their dogs and have nearly been run over along that stretch of the road. He said they do not want a business going in on Rambler Inn Road because he moved there for the quietness of the area.
- 2. Paul Logue who resides at 1205 Rambler Inn Road. He stated he is opposed to the business wanting to go in at 1193 Rambler Inn Road. He stated that one wedding had already taken place. He noted that the City of Arcade has a sign up for the driveway showing "blind driveway" and the traffic through there is scary and dangerous due to the "S" curve navigating that curve. He wants it to stay residential.
- **3.** Gordon Wilson who resides at 1212 Rambler Inn Road. He stated he is opposed to the business wanting to go in at 1193 Rambler Inn Road. He stated there is already a lot of traffic on their road and there is the bad curve there. He said he didn't move there 25 years ago for someone to come in with big music and cooking trailers.
- **4.** Leonard Price who resides at 1241 Rambler Inn Road. He stated he is opposed to the business wanting to go in at 1193 Rambler Inn Road. He is concerned about noise. They don't want this right next door and are totally against it.
- **5.** Someone then asked what the benefit would be for the business to be on Rambler Inn Road, and no one answered.
- **6.** Kalen Renfroe then stood up to speak because she is the person wanting to start the business at 1193 Rambler Inn Road. She explained what they envisioned as having, which is to have small baby/wedding showers, small weddings, even small "off-site" office meetings utilizing the barn on their property. The max number of guests would be 50. It was brought up that a wedding was recently held there, and she explained that the wedding was for her son and happened during a time when her husband was in the hospital recovering from a liver transplant and she was not on site to control the planning. She stated that no other event would be that large and she does not want it to be a large venue. She had people requesting to use her barn and wanted to do the right thing a come before the council to first request a business license. She mentioned that their home is their home office for their small business, Uncle Chet's BBQ. She explained she had no intentions of disrupting the family life of the residents who live on Rambler Inn Road.
