Council Member Denise Black shared that we were looking at hosing a movie night on July 15, 2023, and discussed options on how we would select a movie for the event.

f. Police Department.....Chief Mike Adams

Chief Mike Adams was absent and Sgt. James McNatt provided the statistical report for the Month of April.

### 6. UNFINISHED BUSINESS:

Tabled on February 13, 2023, March 13, 2023, and April 10, 2023

- **a.** Jared Lill Requesting a Business License to operate *Rhino Mini Storage* at the Corner Hwy 82 South and Hwy. 129, Jefferson, GA 30549.
  - Frank Pittman with Pittman & Greer Engineering, P.C. came in to represent the applicant and was offering information and wanted to be available to answer any questions that might come up relating to the project. He stated the property was zoned C-2 with no conditions on it at this time. He stated that they are providing a buffer of 115 ft which is more than the code requires.
  - Attorney Jeff DeLoach introduced himself and wanted to share that he sent a letter to the city which is required by law and wanted to share a few points on the project and that it was not intended to be or create an adversarial environment. He stated this applicant is not a national owner but someone local and wants to be a good resident. He shared that this site has limited use due to the lack of water and sewer available and this would be a productive use.

- Mayor Haynie expressed his concerns and that this was not the type of business the citizens of Arcade wanted in our city. He stated that he understood this business was being permitted due to an error but that he was unhappy with the decision being made.
- Council Member Jenny Buley spoke and asked about a landscape buffer.
- Mr. Pittman responded that they are providing an added buffer beyond the city's required 20-foot buffer of 115 ft. They are aware that this is not the place for conditions, however they stated they would be happy to make sure the neighbors are protected and that it will be a nice landscape buffer.
- Council Member Ron Smith stated that it was an adversarial atmosphere and that the realization of what is stated in a meeting and what is done is two different things.
- Mayor Haynie expresses concerns about how they will combat the problem of making sure that hazardous items are not being stored on site. He is concerned about the open storage area that could become a junk yard for boats and campers.
- Mr. Pittman states they are in the storage business, and they would be willing to add something to the plans to address those concerns. He stated that they don't want something trashy because that doesn't attract customers if it looks trashy.

Motion made by Council Member <u>Ron Smith</u> very reluctantly approved the business license request from Jared Hill at the corner of Hwy 82 S. at Hwy 129 to operate **RHINO** *Mini Storage* in accordance with all C-2 Land use management codes and City Ordinances.
